WOSH'S "33 DRIVERS GO FAST & TURN LEFT" CONTEST OFFICIAL RULES

The Station will conduct the **WOSH's "33 Drivers Go Fast & Turn Left"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Caller one (1) to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>*Time Delay*</u> <u>*Between Over-the-Air Analog Signal and Internet Broadcast:*</u> Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-theair signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Contestant will be assigned a driver in the 2024 Indianapolis 500. Once all drivers are assigned, the qualification period is completed.

On or about 7:00am CT on May 28, 2024, Station will select four (4) potential 4. winner(s) based on the results of the 2024 Indianapolis 500 car race held on or around Monday, May 27, 2024. If the race is delayed for any reason, contest results to be delayed until race is completed. Winner 1 (one) will be the contestant assigned to the driver finishing first in the 2024 Indianapolis 500. Winner 2 (two) will be the contestant assigned to the driver finishing second in the 2024 Indianapolis 500. Winner 3 (three) will be the contestant assigned to the driver finishing third in the 2024 Indianapolis 500. Winner 4 (four) will be the contestant assigned to the driver finishing in last place in the 2024 Each winning entrant will be contacted using the email address and/or telephone Indianapolis 500. number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules).
