WWWX'S "JIMMY EAT WORLD WW 042625" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WWWX ("Station"), 491 South Washburn Street, STE 400, Oshkosh, WI 54904, during available business hours Monday through Friday, on the Station website www.fox969.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the WWWX's "Jimmy Eat World WW 042625" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

Eligibility. Winner Selection. Failure to respond to the initial verification contact within three (3) days of notification or

failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
